

Call for submission of applications for an endowment grant

The Endowment Fund Praha ve filmu Prague Film Fund is announcing a call for submission of applications for an endowment grant for projects, the subject of which is a film or series in which the City of Prague is depicted as the City of Prague and which is intended for international distribution in cinemas, via television broadcasting, television rebroadcasting or video-on-demand services.

Grant proceedings shall be governed by both the Statutes of the Endowment Fund adopted by the Administrative Board on 21 December 2017 and the Conditions for provision of endowment grants which were adopted by the Administrative Board on 21 December 2017.

Start of filming shall be understood to mean principal photography for the film or series/series episode. Preliminary filming, tests, filming of trailers or teasers, filming for the purposes of casting or scouting etc. shall not be regarded as start of filming for these purposes. The City of Prague is depicted in the audiovisual work as the City of Prague. The audiovisual work must be intended for international distribution in cinemas, via television broadcasting, television rebroadcasting or video-on-demand services. |
